- g. The School has two adequately equipped computer lab with not less than 30 computers and Proper software along with facility of high-speed Wi-Fi connectivity.
- h. The school will open the sections only as per the infrastructure facilities available in the school. The number of students in a class will be restricted to a maximum of 40.
- i. Qualified and trained teaching staff as per section teacher ratio of 1:1.5 will be maintained to teach various subjects.
- j. The school and its records will be open for inspection.
- k. As per Rule 13.3 and 13.3 (i), the school will supply all information within the prescribed time given for its furnishing to the authority concerned. School shall prepare its annual report containing all information and upload the same on the school's website before 15 September of every year.
- I. The accounts will be audited and certified by a Chartered Accountant and proper accounts statements will be prepared in the name of school.
- m. The school will strictly adhere to all rules regarding safety of students including Firefighting and Transportation, potable drinking water, clean healthy and hygienic toilets for boys and girls separately.
- n. Teachers are informed to strictly avoid Corporal Punishments
- o. Facilities for physically challenged student(s) are provided.
- p. The school will take care of Health, sanitation and fire safety requirements as mentioned in rule.
- q. The school has a duly constituted a committee for protection of woman and children from sexual harassment at school.
